Sending parcels to Mifa

2 options

> **Avec le transitaire recommandé du Mifa**

> *With Mifa recommended shipping agent*

The service provider recommended by Mifa, Film Events Logistics by Ganertrans, offers a group shipping service to Mifa from the Paris region. **This service is subject to a fee:** contact the provider directly (contact details opposite) to receive a quote.

Sending parcels to Mifa

A paid group shipping service from the Paris region is offered by our recommended provider, FILM EVENTS LOGISTICS by GANERTRANS, allowing you to benefit from preferential rates.

Shipments from abroad

Shipments from abroad (including Europe) must arrive at CDG no later than June 16th 2026, to clear customs in time. Otherwise, shipments must arrive no later than June 18th 2026 (customs-free) at the following address:

Shipments from within France

For shipments outside of Paris, pickups must be made no later than June 17th 2026.

Pickups in Paris/Île-de-France will be made by FILM EVENTS LOGISTICS BY GANERTRANS on Thursday June 18th during the day, and on Friday June 19th 2026, in the morning. The truck for Mifa will leave the Paris region on Saturday June 20th 2026. The goods will be delivered directly to your booth on Monday June 22nd 2026, in the morning.

Packaging storage and parcel return from Mifa

FILM EVENTS LOGISTICS BY GANERTRANS can provide storage for your empty packaging during the event.

For returns, collection will be made directly from your booth on the last day. Delivery will be available in Paris/the Paris region on Tuesday June 30th, on Wednesday July 1st for Europe, and from Thursday July 2nd 2026 for the rest of the world, depending on the destination.

Empty boxes can be provided, along with a shipping order form to be completed with the necessary information for the proper return of your parcels. For more information, please contact the service provider directly: FILM EVENTS LOGISTICS BY GANERTRANS (contact details opposite).

You can send parcels to Mifa yourself, working with the service provider of your choice, provided you **comply with the shipping dates and procedure outlined below.**

1 – Take note of the Mifa parcel desk’s opening hours

The Mifa takes place in a temporary venue and the parcel desk to receive goods is set up on site on **Friday 19th June 2026** and removed on Sunday 28th June 2026. This is why **it is necessary to adhere to the following delivery and return dates:**

> On-site parcel collection period

From **Friday 19th June** to Thursday 25th June 9:00 am to 6:00 pm and Friday 26th June, 9:00 am to 2:00 pm.

> On-site return shipment period

Thursday 25th June to Saturday 27th June 2026, 9:00 am to 6:00 pm

Important: Please inform your carrier of our opening hours for deliveries and returns. We cannot accept or return parcels outside these opening hours. The organiser cannot be held liable for any theft or damage to goods stored by them awaiting delivery to the stands or return shipment at the end of the Mifa.

2 – Schedule the shipment (and, if necessary, the return shipment at the end of the event) of your parcel

Each parcel and equipment **must display** the following information:

Please notify your CITIA/Mifa contact indicating the nature of the parcel, the expected delivery date and the name of your service provider.

Shipping costs and import taxes: When sending your parcel, please specify on the shipping label that you will pay the shipping costs and, if necessary, the import taxes (which are entirely your responsibility). Under no circumstances will the Mifa management pay the duties and taxes on goods delivered to a participant.

Customs procedures: If you use a service provider other than our official service provider, please ensure that they comply with customs procedures, otherwise you may not receive your equipment.

3 – Organise the storage of your packaging

Please note that for security reasons it is not possible to store cardboard packaging or other combustible materials on the stands or inside any extra stocks stored on the stands during the event. Therefore, we ask you to collect all packaging before the start of the event and store them outside. Our recommended shipping agent can store some empty packaging during the market under certain conditions.

4 – Collect your parcel on-site

To collect your parcel go straight to the Parcel Desk (located in the Impérial car park). If your parcels are big and bulky, our on-site technical team can assist you in getting them to your stand.

5 – Drop off your parcel for return shipment (if necessary)

Exhibitors wishing to return their packages at the end of the event must arrange this return in advance with their chosen shipping agent. Returns can only be made from Thursday, June 25th to Saturday, June 27th, 2026, between 9:00 AM and 6:00 PM. It is also possible to arrange return shipping with a recommended shipping agent.
